The Panel met with the President, Vice President for Academic Affairs + Registrar, the Head of the Faculty of Enterprise and Humanities, the Head of the Department of Humanities and Arts Management and members of the Programme Team.</p> <p>The Panel members were issued the proposed Programme Document before the meeting.</p> <p>Following a review of the documentation provided and presentations and discussions with IADT Management and Programme Team members, the Panel were satisfied that IADT meets the prerequisites of the Qualifications and Quality Assurance (Education and Training) Act, 2012 and is eligible to apply for validation of the three-year BA (Hons) English + Equality Studies. The Panel were satisfied to recommend this programme for validation with no conditions and some recommendations.</p>

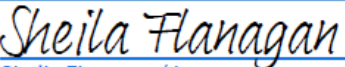
