Yes	<p>The Programme Validation Panel was a hybrid meeting held on Campus in IADT, in the Board Room, Roisin Hogan House and online via MS Teams on Tuesday, 21 March 2023. The Panel met with the Vice President for Academic Affairs + Registrar, the Head of the Faculty of Enterprise and Humanities, the Head of the Department of Entrepreneurship and members of the Programme Team.</p> <p>The Panel members were issued the proposed Programme Document before the meeting.</p> <p>Following a review of the documentation provided and presentations and discussions with IADT Management and Programme Team members, the Panel were satisfied that IADT meets the prerequisites of the Qualifications and Quality Assurance (Education and Training) Act, 2012 and is eligible to apply for validation of the <b>BA (Hons) Business + Digital Technology</b>. The Panel were satisfied to recommend this programme for validation with no conditions and some recommendations.</p>

Yes	<p>Having considered and discussed the objectives and outcomes of the programmes with the programme team, the Programme Validation Panel were satisfied that the aims and objectives are clearly defined in the programme proposal document, and this programme is consistent with the Bachelor of Arts award sought.</p> <p><b>Commendation:</b> The Programme Validation Panel commended the quality of the programme document, which was clear, thorough, and well-presented.</p>

The programme team confirmed graduates would typically progress into a business role, within a technical space, being a bridge between business and technical development.</p> <p>The Panel suggested that graduate pathways and career options are made clearer for prospective students.</p> <p>The Programme Validation Panel were satisfied overall that the programme's access, transfer and progression arrangements are satisfactory.</p>

Yes	<p>The Programme Validation Panel thoroughly reviewed the programmes written curriculum, and discussed different aspects and each of the modules with the programme team. Overall, the members of the Panel were satisfied that the written curriculum is well structured and fit-for-purpose.</p> <p><b><u>Recommendations</u></b> A number of recommendations were made relating to this programmes curriculum:</p> <p><b>Recommendation 1:</b> The Programme Validation Panel recommended the Accounting and Financial Modules, “Accounting Fundamentals” and “Financial Strategy”, are updated in the programme document to clarify the module learning outcomes and content and a more detailed description of the syllabus structure and topics covered. A suitable text e.g Accounting for non-accounting students by John R Dyson et al should be included in the reading list for the Accounting fundamentals mofule. There should be an explanation the assessment methods for both modules.. The CIMA study text Financial Management is recommended for the Financial Strategy module.</p> <p><b>Recommendation 2:</b> The Programme Validation Panel noted many modules included some potentially older texts or references on reading lists. The Panel recommended all reading lists are updated to include the most recent editions of textbooks and online resources, and ensure they are monitored and updated regularly.</p> <p><b>Recommendation 3:</b> Consider reviewing the language used in the learning outcomes descriptions for modules. Learning outcomes should use action verbs that indicate what the learner is expected to be able to do at the end of the period of learning.</p> <p><b>Recommendation 4:</b> The Panel suggested incorporating content on Cyber Security into the curriculum would be beneficial in addition to content included in the “Data and Cyber Law” Module.</p>

The Programme Team also confirmed that guest lecturers, including alumni, business and local community representatives, are a regular feature on programmes in the department.</p> <p>The Programme Validation Panel was satisfied that there are sufficient qualified and capable programme staff available to implement this programme as planned.</p>

The Panel were very satisfied with the quality assurance of the mechanisms in place to ensure learning outcomes are met.</p> <p><b>Commendation:</b> The programme team was commended for the work placement module, which the Programme Validation Panel considered excellent. They were impressed by the Institute's existing structures in place, and collaboration with large number of employers.</p> <p>The Programme Validation Panel were satisfied the learning environment is consistent with the needs of the programme's learners.</p>

**3.5.2** The Programme Validation Panel were impressed with the proposed programme and believed it was well rationalised with good evidence and an excellent mix of business and technology modules.

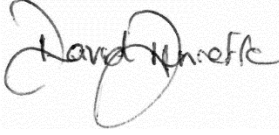

**3.4.1 Recommendation 1:** *The Programme Validation Panel recommended the Accounting and Financial Modules: “Accounting Fundamentals” and “Financial Strategy” are updated in the programme document to clarify the module content and provide more detailed description of the structure syllabus and explanation of assessment methods.*

The content as presented is a modification of a template that has been used successfully in several other course documents. It is indeed not as detailed as one might find on a traditional accounting or business programme, it is more thematic in style and malleable to suit the evolution of a new programme and the "applied" nature of it. The first financial module front-loads the basics, the second gives expression to them and the third module requires synthesis and consolidation. Except for the final assessment in the final year, all assessments are class-based spreadsheet tests following each episode of class material. I consider this to be self-explanatory as written. The final assessment in the final year will be the capstone integrated across all modules project through a financial lens (as we already do on the DL840 Digital Marketing degree). This has yet to be designed by the team, so it is difficult to elaborate more on.

**3.4.2 Recommendation 2:** *The Programme Validation Panel noted many modules included some potentially older texts or references on reading lists. The Panel recommended all reading lists are updated to include the most recent editions of textbooks and online resources, and ensure they are monitored and updated regularly.*

All modules were reviewed for more recent and relevant reading lists. The following modules were updated with more recent editions:

1. Y1: Learning in Business
2. Y1: People in Organisations
3. Y1: Introduction to Data Analytics
4. Y1: Digital Marketing
5. Y2: Data and CyberLaw
6. Y2: Business Analysis & Project Management
7. Y2: Content Creation
8. Y3: Strategic management
9. Y3: Big data in business
10. Y3: Advanced Digital Marketing
11. For the financial modules there is no core text, as most texts are pitched to traditional accounting programmes and traditional accounting students (ie those who will work in the profession), even those that claim to be for non-specialist accounting students. As mentioned in the module documents knowledge and skills are delivered through PowerPoint presentations and spreadsheet exercises. However, students are referred to online resources (ever changing) and the handful of accounting technician textbooks in the library for reference should they wish to.

**3.4.3 Recommendation 3:** *Consider reviewing the language used in the learning outcomes descriptions for modules. Learning outcomes should use action verbs that indicates what the learner is expected to be able to do at the end of the period of learning.*

All modules were reviewed for learning outcomes. Changes were made in accordance with recommendation 3 in relation to the following modules:

1. Business Enterprise Management
2. Introduction to Digital Marketing
3. Data and Cyberlaw – Learning outcomes are more clearly specified.
4. Enterprise Cloud Systems
5. Business Analysis and Project Management
6. Advance Digital Marketing

**3.4.4 Recommendation 4:** *The Panel suggested incorporating content on Cyber Security into the curriculum would be beneficial in addition to content included in the “Data and Cyber Law” Module.*

On review of the Data and Cyber Law module, we changed the following to incorporate cybersecurity:

- Summary of the module
- Minimum intended learning outcomes
- Rationale
- Indicative content
- Reading lists

The second CA (the audit) will include cybersecurity.
