- 4. Staff
- 5. Client
- 6. Others
- 1. Requests shown in the Business/Interest Groups category would include requests for **non-personal records** from: business people, interest groups, solicitors, accountants, trade unions, etc.
- 2. Requests shown in the Oireachtas/Public Representative category would include requests from Members of the Oireachtas and from elected members of Local Authorities. 3.
- 3. Requests shown in the Client category would include a request for records which related primarily to services that the requester had received from a public body e.g., Request from a Student to a body in the education sector etc.
