International Students Fee Information 2024 - 25 Undergraduate Programmes

Programme fees for International Students for our undergraduate programmes for the academic year 2024-25 is €13,500 per year of study. In order to qualify for fees at the full EU rate (€3,819), one of the following must apply:

- (a) For all applicants aged under 23 on 1 September of year of entry to a programme:
 - Parent(s) must have been ordinarily a resident in the EU/EEA/Swiss Confederation and UK for three of the five years prior to the applicant commencing a programme at IADT

and

- Applicant/student must have been ordinarily resident in the EU/EEA/ Swiss Confederation and UK for three of the five years prior to commencing a programme at IADT
- (b) For all applicants aged 23 or over on 1 September of year of entry to a programme:
 - Applicants over 23 years of age are considered independent, mature applicants. The applicant/student must have been ordinarily a resident in the EU/EEA/Swiss Confederation and UK for three of the five years prior to commencing a programme at IADT.

Criteria for Qualifying for EU Fees

Relevant documentation will be required to verify eligibility for EU Fees. This will include verification of residency in EU/EEA/Swiss Confederation and UK for three of the five years prior to commencing a programme in IADT. Examples of documentation required:

1 Copy of your stamp/visa/GNIB card/passport for Ireland

AND

- 2 Any of the following that can verify living in the EU/EEA/Swiss Confederation and UK for three of the five years prior to commencing a programme in IADT:
 - End of Year Statement (P21) or EU equivalent, one per year
 - Social Welfare statements or EU equivalent, one per year

AND

3 Letter confirming Secondary School Education (for applicants under 23 years of age)

Important Notes

- Please note that it is the applicants/students responsibility to ensure they have the correct visa/stamp to study in Ireland.
- Documentation should only be submitted following receipt of offer of a place on an undergraduate course in IADT.
- If you do not qualify for EU Fees, and have been deemed to be on NON EU fees then, this is the fee status that applies for the duration of your undergraduate programme.
- If you are providing documentation, please only give <u>copies</u>
